## More Laws ?? Aren't they enough?

- Governance is not about enacting more legislations and formulating regulations
- We have enough of laws some archaic and antiquated as one may put, should be scrapped or made relevant
- It is more of implementing the legislations & regulations in its true spirit
- Any number of legislation being framed or regulators appointed, would not usher Good Governance, if there is an all encompassing disregard in following and implementing them



## India at 65 Governance in freeze

- We have well defined rights but lack in well prescribed duties, so that one can be held accountable when breached
  - Those who govern us:
    - Do not have <u>specific</u> duties or responsibilities (duties)
      are vague and more like broad vision statements)
    - Do not have constitutional obligation cast on them
      - To protect the revenue derived from the taxes we pay
      - To defend us from internal & external threats
      - To serve us & provide the basic necessities
- We do not have a legal benchmark, listing the punishment when they fail to deliver the above

# India at 65 How free is Indian Enterprise?

- A manufacturing unit needs to comply with nearly 70 laws & regulations
- Even to comply with the multiple laws & regulations one has to fill forms each of around 20-30 pages and undertake multiple visits to various government offices
- File as many as 100 returns in a year and face multiple inspections
- More the touch-points & complication, corruption flourishes and its tentacles sharpens


# India at 65.... Unshackle the Indian Enterprise...

- Policy making being changed with retrospective effect

- A country where about 70% of population leaves below \$2 a day, preservation of wild life is given more priority than feeding the millions – a case of misplaced priority or is there more to it harassment leading to greater corruption??

# India @ 65 Corruption in Unison

Non-compliable provisions in most revenue legislations....

- Lead to all being defaulters differing only in scale
- Big evaders can afford to buy the system out
- While genuine ones are unable to match the payout of tax evaders to keep the officials happy
- Leading to even the genuine ones turning evaders in the longer



## India @ 65 Growth at Incubator battles Corruption

- Land, Natural Resources, Airwaves, are all imperative in today's business – having complete government control over them makes honest business impossible
- When an economy grows, some sectors are likely to grow faster – slight manipulation in regulatory or licensing rules in these sectors result in windfall gain for a handful
- Mutually enhancing collusion a syndrome that is inflicting detrimental blow on our economy which is at the initial throes of development





# India @ 65 Inspector Raj still in full swing...

- License raj may be over but some of its vestiges rule IT, Excise, Police, X, Y, inspectors force their way
- As the debate of discretion and allocation rages
- Tension between parliamentary supremacy and the rule of law remains unsolved
- Investments, similar to Politics is getting regionalized even big business houses feel the heat of state level politics


### India @ 65 Raid Raj mentality reigns

- During the pre-independence era, the police used to raid households at odd hours in search of freedom fighters and harass them at the slightest pretext

# India @ 65 Rule of law replaced by rule of men


We do not see convictions

- Guilt is proved by raids
- The person is put in jail and released in a few days without any trial
- There is no compensation- but the loss of reputation is irreparable
- Fear of Raids much greater than Raids itself

# India @ 65 All's (not) Well

- Fear of India moving to a new Hindu growth rate of 5-6% much less than the 9-10% "Chindia" dream
- Corruption is morally abhorrent and evokes popular revulsion
- Hurts the Nation economically as policy paralysis precipitates
- Fear of any supposed wrongdoing leading to bureaucratic inaction
- The Aam Admi suffers as welfare of poor is only possible from revenue generated through overall economic growth
  - Fewer jobs & more unemployment
  - Strain on welfare projects

- Be more assertive by quietly acquiescing, we become party to corruption
- Must make our views heard
- Must support those who stand and try to fight corruption
- Individually oppose corruption wherever we find it

### Extortionary

- The common man and the poor most hit
- Forced primarily by government
  bodies and enforcement agencies
- Citizen has no choice ends up losing time/money /opportunities if denies the bribe
- Less talked about and not highlighted by media since sum involved in individual cases is much less though adds up to a humungous total

#### Collusive

- Paid to public authority to fleece the general public
- Eg. Government Contracts, tenders, projects, etc
- Loser is the general public as cost of public service goes up and efficiency goes down
- All big scams that we hear about are of this type
- Does not affect the common man in his day to day life
